



Freemotion.Logic 'Control Monitor'

Manage and monitor your access easily and mobile. The intuitive web application is the perfect addition to your access control system.

Simple Monitoring and Control

- Keep track of the capacity usage of your gondolas or other access areas.
- Open or close the entrances directly from the application.

Fraud Detection and Prevention

- Detect by means of photo control whether non-transferable tickets were passed on.
- Prevent fraud by comparing the person category of the ticket (i. e. Child) with the entering person.

On-Site Customer Service

- Customers blocked at the entrance can be helped quickly and directly to clarify the cause, i. e. too few points on the card, card no longer valid, locked card, etc.
- Manual control of gondola counters, i. e. as for people with special needs who cannot pass through the regular access control readers.

Mobile Use

- Work independent of time and place. With a tablet you can use the Control Monitor application at any location.
- Perform extended mobile ticket checks directly at the access readers.

Features

- Browser-based web application, running also on smartphones or tablets, for displaying and controlling of access readers, gondola counters and ticket details including photos.

Functions

- Easy to use (also supports touch screens)
- Provides clearly structured overview of reader status, ticket details (including ID photo) and gondola counters
- ID photo check at the gate allows for matching the displayed photo against the person at the gate
- Configurable display of reference and comparison photo
- Manual release or lock of individual reader or gate via push button
- Easy manual intervention or resetting of gondola counters
- Option for showing and hiding individual access readers and gates ensures optimum overview
- Display of reader transaction details, including access history
- Flexible application range with mobile device, e. g., for temporary spot-checking at individual lift stations

Uses and Applications

- (Mobile) monitoring and control of access readers/gondola counters at the ski resort
- The application is intended to prevent ticket fraud and improve customer service
